- Application by Electronic Mail Using Mobile Signature or Secure Electronic Signature: Application can be made by sending an e-mail to <u>pirnakis@hs01.kep.tr</u> by filling out a petition or "Application Form" signed by the Applicant with a mobile signature or secure electronic signature.
